# WSGA Fall 2008 Board Meeting November 20, 2008 – Online Meeting Minutes

#### 1. Call to order

### 2. Open the floor to nominations for WSGA board

Existing nominations were reviewed. No additional new names were put forth so the online nomination portion of the meeting was closed.

#### 3. Old Business

- Transcript of the August 20, 2008 online meeting was reviewed and approved.
- Treasurer's report was reviewed and approved. Details:
  - Website Software and Hosting: \$350
  - o Office Supplies: \$25
  - o Campout Reservations: \$2700 (much to be refunded when extra days are canceled)
  - Chapter Banner for SW WA: \$85
  - \$200 Chapter Distributions IE, CC, 48N, CW.
  - \$300 Puget Sound Distribution coming for Holiday Party
  - o Available cash on-hand: Main Acct \$2087, Debit \$673, Paypal \$212, Total \$2972
- 2009 Geocoin update: Artwork submitted to Coins & Pins. Side one WSGA logo, Side two Chapter outlines with chapters in different colors. Still waiting on colors from SW and CC.
- 2008 Campout update: No update under old business.
- Other: No additional old business was discussed.

#### 4. New Business

- New website and forum: Same software used by Groundspeak (IPBoard). Slowly moving features from the old site. New features in work: Archived Cache rescue program (aka GeoTrash). Brian to develop a tutorial on various aspects of site manipulation and navigation.
- Upcoming board election update on nominations, online voting procedure, etc.: Voting is set up and ready to go. Just waiting for Dec. 1<sup>st</sup> to open nominations.
- Elma RV contact: The WSGA has no interest in co-hosting an event. All further contact will be declined.
- 2009 membership drive: remind members to renew online, membership cards, patches, etc.: No actual discussion during meeting, however emails reminders will be sent with Election emails and reminders in the President's Blog and email.
- Assistance needed by secretary for membership cards, mailing?: It was decided that membership
  packets would be sent out quarterly to reduce the 'onesy twosey' aspect of incoming memberships.

- WSGA gear update: Spirit Shop, Advantage Sports, sales tax issues.: It was decided to place a small order (\$720) with Advantage Sports (the company Mr. Geobells works for) for us to keep items 'in stock' for easy selling and shipment. Laurie offered to be responsible for shipping. Initial details:
  - Embroidered hats/visors: \$8.00: Khaki with green embroidery, Green with white embroidery.
  - Short sleeve tees, any size from kids small to adult 4XL: \$5.50/white, \$6.00/green
  - o Long sleeve tees, any size from kids small to adult 4XL: \$7.50/white, \$8.00/green
  - o Custom name, team names, etc. added for \$5.00
  - Also working on vinyl WSGA stickers and/or window clings, cost about \$1.00
  - o The lanyards we already have
- Other: No other new business was discussed.
